Risk of impact injuries and spinal damage	<ul style="list-style-type: none"> <li>▪ Full co-operation from group leaders in group control and discipline.</li> <li>▪ Clear instructor briefing</li> <li>▪ Instructor to remain vigilant and repeat instructions before launch</li> <li>▪ Participants reminded about hand placement and head movement before every departure.</li> </ul>	Y Y Y Y	Instructors to be signed off by TA and records logged on Cinolla. Entrapment in the ropes/Lanyard and or Pulley	<b>To All:</b> Risk of hair, hands or neck being caught in rope/lanyard or pulley causing cuts, abrasions, lacerations, bruising, spinal damage, death	<ul style="list-style-type: none"> <li>• Ensure all hair is tied back and not able to get into trolley.</li> <li>• Ensure the lanyards are too long for participants to be able to reach up and touch with hands.</li> <li>• Safety Lanyards to be slack enough that no chance of forming loop that can go around neck and tighten upon hitting the brake</li> <li>• Instruct participants to either hold both lanyards or none at all</li> </ul>	Y Y Y Y	Instructors to be signed off by TA and records logged on Cinolla. Poor Light/bad weather affecting visibility	<b>To All:</b> Risk of poor communication between instructors leading to major injury and or death	<ul style="list-style-type: none"> <li>Session ended if conditions become unsafe, i.e. visibility poor or too cold, and reschedule for better light.</li> <li>Activity not permitted after 6pm due to planning constraints.</li> <li>Mobile phones in use between instructors on platforms.</li> </ul>	Y  Y	Mobile Phones required on session by both instructors	Instructors	LOW
